CONSENT AND RELEASE FORM FOR CHILDREN'S CAMP

I, the undersigned parent or guardian, hereby consent to my child, _____, who is _____ years of age, participating in the activities connected with the trip to and from and the time at Camp Helen in Harvest, Alabama, an activity sponsored by First Baptist Church Ardmore Inc., either as a 3 Day Camper from Monday, June 24, through Wednesday, June 26, 2019 or as a Day Camper on Tuesday, June 25, 2019.

I do hereby agree to hold First Baptist Church Ardmore and its agents and employees, harmless from any and all liability, actions causes of actions, claims, expenses, and damages on account of injury to my child or property, even injury resulting in death, which I now have or which may arise in the future in connection with the activity or participation in any other associated activities.

I expressly agree that this release, waiver, and indemnity agreement is intended to be broad and inclusive as permitted by the law of the State of Alabama, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
